Hearing Aid Assessments and Re-assessments during quarter ending 31 March 2006

This is the first statistical bulletin presenting information on hearing aid assessments and re-assessments by audiologists in Northern Ireland, for the quarter ending 31 March 2006. Information has been derived from the quarterly collection AUD1, and monitors information on both adults and children fitted and assessed for hearing aids during the quarter, complaints received, and cost of aids issued. In addition, the return monitors complete and incomplete waits for assessment during the quarter, and the length of time patients were waiting or had waited following referral to Audiologist (specified time bands).

Key Findings

Patients Fitted:

- 2,772 patients were fitted with a digital hearing aid or analogue hearing aid during the quarter ending 31 March 2006, 2,575 digital hearing aids and 197 analogue hearing aids.
- Of the 2,772 patients fitted during the quarter, over half (1,557) were new patients.
- The Eastern HSS Board had the highest number of patients fitted with hearing aids during the quarter (1,229), 591 in the Southern Board, 530 in the Western Board, and 422 in the Northern Board.
- In addition, 1,151 existing clients were issued with digital hearing aid replacements or fixes during the quarter (These are not included in the information above for patients fitted, as patients may have already been fitted during the quarter).

Patients Assessed:

 2,542 new and existing patients were assessed for hearing aids during the quarter ending 31 March 2006.
 Of these, 33 adults were assessed as unsuitable for a hearing aid.

Cost of Hearing Aids:

 Information on the cost of aids was not available in the Northern Board. However, 3,437 aids¹ were issued across the Eastern, Southern, and Western Boards during the quarter ending 31 March 2006 at a cost of £221,886.

Complaints Received:

 No complaints were reported by Audiology Departments in Northern Ireland during quarter ending 31 March 2006.

Completed Waiting Times:

- 2,680 patients had their hearing aid assessment / reassessment ² completed during the quarter ending 31 March 2006.
- Of these 2,680 patients, 52% had been waiting less than 3 months from referral to an Audiology Department until the aid was fitted, 21% waited 3 to 6 months, 17% waited 6 to 12 months, and 11% waited 12 months or more.

Incomplete Waiting Times:

- At 31 March 2006, 2,184 patients were waiting for their hearing aid assessment / re-assessment ² to be completed.
- The highest proportion (50%) of these patients were waiting for 6 to 12 months, 26% less than 3 months, 19% 3 to 6 months, and 5% 12 months or more.

- The enclosed figures for hearing aid assessments and re-assessments are the first in a regular series. Data is collected on the AUD1 quarterly return, which provides the DHSSPS with aggregate data on children and adults assessed and re-assessed for hearing aids in Northern Ireland.
- 2. The information presented for the quarter ending 31 March 2006, is based on data reported by 12 audiologists, working in the following hospital / community Trusts; Royal Group of Hospitals, Belfast City Hospital, Mater Hospital, Ulster Community & Hospital, Laganvalley Hospital, Downe Hospital, Causeway / United Hospitals, Daisy Hill Hospital, Craigavon Area Hospital, Armagh & Dungannon HSS Trust, Altnagelvin Hospital, and Sperrin Lakeland HSS Trust.
- 3. The information in this bulletin is presented according to HSS Boards, and is based on the location of the hospitals / Trusts, and not where the client lives, i.e. a client from the Northern Board may be seen in the Royal but their details will be included in the Eastern HSS Board.
- 4. Numbers from 1 − 5 have been suppressed and are shown as hyphens. Percentages are shown rounded to whole numbers but where the numerator was five or less, or the denominator was 10 or less, they have been suppressed and replaced with a hyphen.
